

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.locohanafranchise.com](http://www.locohanafranchise.com), and Biggys Beach Grill Holdings, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Biggys Beach Grill Holdings, LLC include [www.locohanafranchise.com](http://www.locohanafranchise.com) and Locohana Tropical Grill. The Locohana Tropical Grill website is a Franchise Landing Page site. By using the Locohana Tropical Grill website, you consent to the data practices described in this statement.

## Collection of your Personal Information

Locohana Tropical Grill may collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Sharing Information with Third Parties

Locohana Tropical Grill does not sell, rent or lease its customer lists to third parties.

Locohana Tropical Grill may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Locohana Tropical Grill, and they are required to maintain the confidentiality of your information.

Locohana Tropical Grill may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Locohana Tropical Grill or the site; (b) protect and defend the rights or property of Locohana Tropical Grill; and/or (c) act under exigent circumstances to protect the personal safety of users of Locohana Tropical Grill, or the public.

## Tracking User Behavior

Locohana Tropical Grill may keep track of the websites and pages our users visit within Locohana Tropical Grill, in order to determine what Locohana Tropical Grill services are the most popular.

This data is used to deliver customized content and advertising within Locohana Tropical Grill to customers whose behavior indicates that they are interested in a particular subject area.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Locohana Tropical Grill. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Locohana Tropical Grill website.

### **Security of your Personal Information**

Locohana Tropical Grill secures your personal information from unauthorized access, use, or disclosure. Locohana Tropical Grill uses the following methods for this purpose:

- SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. ### **Right to Deletion**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Locohana Tropical Grill does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.

### **E-mail Communications**
